#### II. Public Speakers

#### III. Executive Director's Report (ROBERT ROSE)

Senate Bill 1721.

Illinois Sen. Steve Stadelman is the lead sponsor for this bill.

- This bill helps homeowners to stay in their homes.
- The bill will reduce the tax sale penalty from 18 percent to 12 percent and be assessed once per year.
- Elimination of the six-month accelerator.

#### **Core Business Activity**

- The 2021 core business activities are our ledger for the year.
- We acquire, sell, demolish, and then track the rehab of our properties.
- The rehabs are not performed by the Land Bank, but we do have strong deed restrictions in place that help to provide the proper incentive for those that are working with us to do those rehabs in a timely fashion.
- 36 dispositions completed this past month.
- The cumulative community wealth, from the start of the Land Bank through February 28, 2021, is tracking what the property was worth before the Land Bank intervened and after the Land Bank intervened. Nearly \$103 million dollars of impact.
- Acquired nearly 2,400 properties ever-to-date.
- Sold over 1,100 ever-to-date.
- 1,200 properties in current inventory.
- 745 properties have been rehabbed ever-to-date.
- 200th rehab celebrated November 2017.
- 500<sup>th</sup> rehab celebrated November 2019.
- On track to celebrate 1000<sup>th</sup> rehab at the end of the year or the beginning of next year.
- 467 tax deeds issued by the clerk awaiting recording.
- Our goal this year is to acquire 800 properties. In the pipeline right now, we have well over 1000 properties in addition to what we have in current inventory.
