# MEETING MINUTES OF THE COOK COUNTY LAND BANK AUTHORITY LAND TRANSACTION MEETING

#### I. Call to Order and Roll Call

### II. Public Speakers

Executive Director Rob Rose notes there are no public speakers.

## III. Transactions Report (DARLENE DUGO)

The Transaction Report covered core business activities; current commercial projects, scavenger sales, and the 2021 focus.

- 136 acquisitions for the month bringing the Land Bank to 26% of goal for the fiscal year.
- 13 dispositions for the month bringing the Land Bank to 38% of goal for the fiscal year, 30 properties are currently under contract.
- The Land Bank is using its grant funds designated for demolition, from Illinois Housing Development Authority (IHDA), strategically to address properties suffering from structural integrity and cannot be rehabbed.

#### **Cumulative Core Business Activities**

- 2,535 Acquisitions
- 1,196 Dispositions
- 1,339 Properties in Inventory
- 814 Completed Rehabs
- 760 Properties Reoccupied
- 149 Demolitions

#### Rehab Pace:

- First rehab completed June 2015.
- 200th rehab celebrated November 2017
- 500<sup>th</sup> rehab celebrated November 2019
- Land Bank is on track to reach 1000th rehab by year-end.

#### Current Inventory Breakdown:

- Vacant Land 1,008 parcels
- Residential Structures 226
- Commercial Industrial Structures 105

#### **Programs in Process:**

Flood Mitigation Buyout Program in Franklin Park. More than 30 properties eligible. There are 5 active participants in the pipeline.

Land Banking Agreements with: IFF Homan Square, IFF Maywood, Sacred Heart Apartment Development, NeighborScapes, IMAN, By the Hand, Berwyn Development Corporation and CNI.

The City of Chicago is putting in \$900,000 for the acquisition of, 13 CCLBA properties acquired under the Land Banking agreement with CNI, and CNI owned. The city has agreed to allow Area Wide Realty to be the developer of those properties.

There were 823 applications received this month. This indicates a strong market.

6429 S. Stewart is now finished. This was the Land Bank's first, largest, multi-family renovation- 48 units. The Stewart Building sat vacant for at least 15 years. Several groups tried to figure out how to make it work, but it was the Land Bank intervention that broke the cycle to get this property back on track. This was a collaboration between CIC, the City of Chicago, and the Land Bank, WPD Management was the developer of this project.

## Tax Certificate Update:

There are 339 deeds going through the point-of-sale requirements, prior to deeds being recorded. Of the 339 deeds, there are 171 commercial parcels, 22 residential parcels, and 246 vacant parcels.

The redemption period for a single-family home is two and a half years. The next scavenger sale has not been scheduled and no word of when it may be scheduled.
