**Cook County Land Bank Authority Announces Vacant Property Holiday Giveaway & Sale** 10 Vacant Properties Across Cook County Will Be Given to Community Groups and Neighbors

**CHICAGO** - The Cook County Land Bank Authority (CCLBA) today announced that they will be offering long-vacant properties throughout suburban Cook County and the City of Chicago at below market-rate, empowering residents, community organizations and local community developers to reclaim abandoned properties within their own neighborhoods while breaking down barriers that exist to access these properties.

From December 15, 2021, to January 15, 2022, individuals and community organizations can explore hundreds of available vacant properties and parcels and apply to have CCLBA take those properties to deed on their behalf. To kick off the program and catalyze community development, CCLBA will give away 10 vacant properties to the first 10 successful applicants that are community organizations or neighbors of the parcels. The available properties are located throughout Cook County, but the majority are located within the following community areas:

"This sale is one step in the right direction toward putting properties into the hands of Cook County's residents and community organizations."

By offering these parcels, CCLBA will address complicated legal filings and costs that often discourage community members from attempting to acquire vacant properties and put them back to productive use. This program will strengthen communities across Cook County by transforming vacancy into equity, improving residents' quality of life and the economic vibrancy of their neighborhoods.

The Land Bank acquires properties that have sat tax-delinquent, abandoned and vacant for years and sells them at below-market rates to qualified community-based developers, who then rehab the properties.
